Participating skater assumes full responsibility for any risk of injury, property damage, or death while participating in activities at this establishment.

Participant and/or their parent(s) or guardian hereby waive any and all claims including, but not limited to, bodily injury including death and property damage they may have against (CENTER CITY EVENTS, U.S. CELLULAR Corporation, its parents, subsidiaries, partners and affiliates, CITY OF KNOXVILLE) and Ice Rink Events, and all sponsors of the ice rink establishment and their subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers arising out of Participant's use of the ice skating rink and all surrounding areas.

Participants and/or their parent(s) or guardians hereby release and hold harmless (CENTER CITY EVENTS, U.S. CELLULAR Corporation, its parents, subsidiaries, partners and affiliates, CITY OF KNOXVILLE) and Ice Rink Events, and all sponsors of the ice rink establishment and their subsidiaries, affiliates, partners, officers, directors, employees, agents, and volunteers from any and all liability for any loss, damage, or expense that the Participants or their respective heirs, assigns and legal representatives may suffer as a result of Participant's use of the ice skating rink, from any cause whatsoever, including but not limited to, negligence or breach of contract on the part of (CENTER CITY EVENTS, U.S. CELLULAR Corporation, its parents, subsidiaries, partners and affiliates, CITY OF KNOXVILLE) and Ice Rink Events, and all sponsors of the ice rink establishment, in the operation, supervision, design, maintenance, or condition of the ice surface, or of the ice rink and all surrounding areas.

Participant agrees to abide by the "Code of Skater Conduct", as read and initialed on reverse side of this posted within the ice rink area, for the use of the ice skating rink and will follow the instructions of the operating staff of the rink. Failure to follow these codes of conduct may result in the termination of Participant's use of the ice skating rink, the rental ice skates, and the surrounding areas without refund.

Participant permits (CENTER CITY EVENTS, U.S. CELLULAR Corporation, its parents, subsidiaries, partners and affiliates, CITY OF KNOXVILLE) and Ice Rink Events to use any photographs, videotapes, recordings or any other records taken while on the ice skating rink premises for publicity, advertising, or any other legitimate purpose, without compensation to the Participant.

 2. Anyone under the age of 18 must have a parent or guardian sign a waiver for them.
 3. No skating without a rink issued wristband.
 4. Skates will be issued at the skate window. Double-blade skates are available for young children.
 5. Skates are to be returned to the skate return window after use.
 6. While wearing skates, please stay within the rubber floor area.
 7. No one is permitted on the ice without ice skates.
 8. No one is allowed on the ice while resurfacing is occurring.
 9. Knoxville's Holidays on Ice reserves the right to interrupt or stop skating for ice resurfacing, special events, or for any other staff-related purpose.
 10. No sitting or climbing on protective dasher boards.
 11. No use of hockey sticks, pucks or balls.
 12. No ice-skating against flow of traffic.
 13. Children under the age of 12 must be accompanied by an adult.
 14. No carrying children on the ice.
 15. No food, beverages or breakable objects are allowed on the ice rink.
 16. No one is allowed to use the ice rink under the influence of alcohol or drugs.
 17. No profanity or obscene clothing allowed.
 18. Follow directions from the Ice Attendant and rink staff at all times.
 19. Report all incidents and accidents to the Ice Attendant or rink staff member immediately.
 20. No reckless skating, camel spins or speed skating allowed.
 21. Rink staff is not responsible for lost or stolen items in the tent area.
